Dear VSA First Responder Supplies and Equipment Vendors and Manufacturers.

I am pleased to announce the inaugural year of the Virginia Sheriffs' Association's (VSA) First Responder Supplies and Equipment Procurement Program; a cooperative purchasing program for supplies and equipment for first responders including but not limited to body armor, weapons, EMS supplies, ammunition, technology, and more. All local government agencies are invited to purchase through this contract.

Since implementation of our Cooperative Purchasing Programs in 2019, we at the Virginia Sheriffs' Association continue to hear positive feedback from public bodies across the Commonwealth of Virginia and throughout the United States. The VSA is excited to work collaboratively with first responder supplies and equipment vendors and manufacturers nationwide. With collaboration, the VSA will provide all public bodies a new, convenient, and beneficial way of purchasing their first responder supplies and equipment. We hope that you will be interested in participating in this year's bidding process.

Enclosed you will find the official bid calendar which outlines all important dates and deadlines leading up to contracts being awarded on June 20, 2024. The 2024-2025 contract will be effective June 20, 2024, through June 19, 2025.

All bidding will be completed through our online bidding system, VendorLink. All vendors who wish to participate must register with VendorLink to have access to submit a bid. Registration will be open February 13, 2024 through April 30, 2024. We encourage you to complete your registration as soon as possible. If you already have an account with VendorLink you do not need to create a new account but do need to ensure you are listed as a Planholder for Bid 25-01-0524. No bids or required documents will be accepted outside of VendorLink, and the Association will not accept any hard bid submissions for Bid 25-01-0524. All vendors will be responsible for entering pricing and percentages, uploading build sheets, uploading option sheets (must include list of models available for upgrades/downgrades), and uploading all required bid documents.

The Association has created helpful tools to utilize as you complete your bid package. These tools can be found within the "Documents" section of Bid 25-01-0524 in VendorLink and include the following: Bid Submission Checklist (part of the Required Documentation Packet), Build and Option Sheet Sample Guide, and VendorLink Vendor Reference Guide. Please ensure you utilize these tools as you complete your bid package.

The VSA looks to our dealer and manufacturer partners for recommendations on which new products to add to our program. As the Association works to prepare the first draft bid package, please complete the "Add/Delete Form", found in the "Documents" section of VendorLink under Bid 25-01-0524,

and provide to Anna (e-mail below) as an excel file by February 27, 2024. We encourage all bidders to pick the most popular base models you wish to include and have all other applicable upgrade/downgrades listed on the option sheet that will be uploaded as part of your bid submission.

We look forward to growing and providing the benefits of our cooperative bid program to even more public bodies throughout the United States. Once you are on the website you will find information on the existing open bids, important documents such as the program's Terms and Conditions, and other bid support documentation.
