RE: 2024/2025 - Tire Contract Year

The Virginia Sheriffs' Association (VSA) has made the decision to execute Section 1.8 *Term of Contract* and extend all current contracts held under Tire Procurement Bid 24-03-1107 for one additional year. Bid 24-03-1107 will remain in effect until November 19, 2024.

All current contracts will extend for one additional year upon mutual agreement. On November 20, 2024, the VSA will publish all rollover contracts as Bid 24-03-1107R. The rollover contract will be effective November 20, 2024, through November 19, 2025. All current contractors have been provided with a Rollover Contract Agreement that is to be signed and returned to [kmitman@virginiasheriffs.org](mailto:kmitman@virginiasheriffs.org) by **Friday, October 25, 2024.**

As part of the rollover contract, all current contractors may submit an updated Authorized Dealer list and Price Sheet to [kmitman@virginiasheriffs.org](mailto:kmitman@virginiasheriffs.org) by **Wednesday, November 13, 2024** should this information need to be revised for the 2024-2025 contract year. All updated Authorized Dealer lists, and Price Sheets will go into effect on November 20, 2024.
